Dear Sir,

We refer to the aforementioned matter and to the decision of the Single Judge of the Players' Status Committee passed on 3 November 2020 and notified to the parties on 10 November 2020.

In this context, we acknowledge receipt of the latest correspondence of Al-Ramtha, a copy of which is herewith enclosed for the information of the coach.

In particular, we have noted from Al-Ramtha's correspondence that the club "would like to know on what bases you have taken this decision" and that it would "like to appeal in front your court against the decision if it is possible". In addition, Al-Ramtha "would like to know the amount of the procedural costs so we could pay it as soon as possible though your bank account".

In this regard, we wish to remind you that in accordance with art. 15 par. 1 of the Rules Governing the Procedures of the Players' Status Committee and the Dispute Resolution Chamber as well as the note relating to the findings of the decision concerned, the motivated decision will be communicated to the parties, if a request for the grounds of the decision is received by the FIFA general secretariat in writing within ten days as from receipt of the findings of the decision. Failure to do so will result in the decision becoming final and binding and the parties being deemed to have waived their rights to file an appeal.

Thus, we kindly ask you to confirm **by no later than 20 November 2020** whether you would like to request the grounds of the decision.

Furthermore, we would like to remind you that a motivated decision issued by FIFA must be appealed in front of the Court of Arbitration for Sport (CAS), if the parties wish to do so.

Finally, we kindly refer you to point 6. of the decision notified to you on 10 November 2020, according to which "The present decision is rendered free of costs".

We thank you for your kind attention to the above.

We have received your NOTIFICATION OF THE FINDINGS OF THE DECISION EMPLOYMENT-RELATED DISPUTE CONCERNING THE COACH MOURAD RAHMOUNI Ref.
